3rd Arab Land Conference

FIG and C7 had recent involvement at the **Third Arab Land Conference** in **Rabat**, 18-20 February 2025, hosted by **Government of Morocco**. The Conference was organized by the Ministry of National Territory and Urban Planning, Housing and City Policy, UN-Habitat, GLTN and the Arab Land Initiative, in partnership with the League of Arab States, UNESCWA, UNECA, the World Bank, BMZ, the Netherlands' RVO, and Morocco land sector stakeholders

This was our first engagement in the **MENA** region for the 2023-26 period. Historically, FIG has not had great membership in the region (apart from a few shining starts), impacting both ways. There is less awareness of global innovations at in the region, and those same innovations, including standards, may fail to take on board the needs and requirements of the MENA region.

FIG C7 delegates and friends, including President **Diane Dumashie**, **Clarissa Augustinus**, **Kholoud Saad**, **Dina Naguib**, **Abderrahim Idris** and **Rafic Khouri** were active in sessions on women's land rights, regional innovations in land registration, the UN-GGIM IGIF and FELA frameworks, and the important role of land professionals in creating transparency and good governance. We also played a role in reviewing the '**Morocco Declaration for Land Governance**' stemming from the event.





FIG Working Week 2025, Brisbane, Australia



- Completed the first full **draft of the planned publication** ‘Framework for Effective Land Administration’. It showcases the experiences, lessons, tools and applications of FELA from FIG Member Associations, since its UNGGIM endorsement in August 2020. The draft will be presented at the Brisbane 2025 Working Week, with a call for review following soon after.
- Continued to work on **awareness and dissemination** of FELA, which despite translation into 5 languages, still work. The above publication will help this.
- Participated in global and regional UNGGIM meetings to explain the role of FIG and further relay stories and applications of FELA. For Q2, this will include engagement with **UNGGIM Americas**, and seeking to deliver online training workshops.

Innovations in Fast-Tracking Land Registration

FFPLA Working Group Workshop 1.0

Background

This workshop presents an opportunity to learn innovative technologies and processes for fast-tracking land registrations to promote tenure security, economic growth, and sustainable development with cost-effectiveness and scalability in perspective.

The workshop will explore technological innovations such as geospatial technologies and mobile applications to enhance data capture, management, and registration processes. It will also delve into process innovations, including simplifying procedures, decentralization with community involvement, and alternative dispute resolution mechanisms. Furthermore, the workshop will discuss innovations in institutional and legal reforms, emphasizing the need for updated land laws that support fit-for-purpose land administration and strategies to strengthen land administration institutions for improved coordination.

Goal and objectives

The **aim** of this workshop is to explore innovations in technology, processes, and legal reforms to fast-track land registration.

The **objectives** are:

1. To examine **technological innovations**, such as geospatial technologies and mobile applications, to enhance land surveying, data management, and registration processes.
2. To investigate **process innovations**, including **simplifying procedures**, decentralization with community involvement, and alternative dispute resolution mechanisms.
3. To discuss innovations in **institutional and legal reforms**, emphasizing the need for updated land laws that support fit-for-purpose land administration and strategies to strengthen land administration institutions for improved coordination.



WG7.3 3D and LADM

As always, there is lots going on with group, led by Peter van Oosterom p.j.m.vanoosterom@tudelft.nl. Note: this group does not use Whatsapp, so get in touch with Peter directly if you'd like to join the mailing list. For Q1, here is the latest.

- Work is almost finished on 2 new publications that WG7.3 has been contributing! Hopefully, we'll see them launched in Brisbane 2025, Working Week. Both are on LADM.
- The first is an overview publication provides the background, development, and ongoing applications of ISO19152 **Land Administration Domain Model** or LADM.
- The second is very practical and aimed at supporting educators in training on LADM. It's titled **LADM in the Classroom** and has been led by ITC Faculty, University of Twente. Stay tuned for both.
- Based on the proceedings from the 2024 12th International LADM Workshop from Malaysia, co-run with the C7 Annual Meeting, the group is working on a **Special Issue** with FIG academic publication partner '**Survey Review**'. It should be out later this year.

WG7.4 AI and Remote Sensing 4 LA

- Supporting and compiling lessons on the rapid developments happening with AI and **applying** those to the land administration domain.
- This includes case applications in **Netherlands, Indonesia and Nepal** – and also all the sessions we've had on AI-applications across 2023, 2024, and now 2025 – at our Annual Meetings and Working Weeks. We hope to see a full overview publication on this soon.
- Meanwhile, **Brisbane 2025** has a full session (and maybe two) on applications of AI in LA. Be sure to get along. This includes automation of tasks in-office, but, also auto-adjustment of cadastral fabrics.

WG7.7 Land Administration Education

Led by **Assoc. Prof. Simon Hull** simon.hull@uct.ac.za, in Q1 this group:

- Published its position paper on the **Teaching Essentials for Responsible Land Administration: Considerations for future education and training**. The paper gives an in-depth evaluation of the Teaching Essentials, highlighting their strengths and drawing attention to several shortcomings. We make recommendations for the updating and improvement of this structured knowledge base that we hope will add value to the existing resource and further its uptake. The position paper was chosen as **article of the month for March 2025** 🎉
- Presented the position paper at the **International Land Management Conference** hosted by the University of the West of England in early March.
- Are working on evaluations of other teaching aids such as the **African Union Guidelines for Development of Curricula on Land Governance**, as well as the compilation of a core body of knowledge for land administration education.

Foreword

It is with great delight that we endorse this FIG position paper. The *Teaching Essentials for Responsible Land Administration (TERLA)*, developed between 2015 and 2018 under the patronage of the Global Land Tools Network (GLTN), marked a pivotal step in advancing the understanding, unity, and practice of land administration globally. We acknowledge the collaborative effort by distinguished scholars and practitioners in the creation of TERLA. It addressed the challenge of teaching the daunting and complex domain of land governance at a country-level. This publication acts as a touchstone. It looks back on that foundation work, unpacking lessons, but also draws on the insights of those valuers and educators deeply engaged with its application to case forward. Representing the joint efforts of the International Federation of Surveyors (FIG) Commissions 2 and 7, this paper recognizes the need to adapt TERLA to the evolving demands of professional education in land administration. We encourage all educators and practitioners in the land administration domain to read and reflect on the contents within, considering how they impact on their own teaching and learning contributions in land administration, and the ensuring of a sustainable pipeline of responsible talent enters our important domain.

- Supporting the development of a new paper on **The Governance of Global Land Sector Semantic Resources**. It should be available later this year.
- Continuing to highlight new and available tools for organizing land governance knowledge, including the Linked Land Governance Thesaurus (**LandVoc**) and the Cadastre and Land Administration Thesaurus (**CaLAThe**).
- These thesauri, based on international standards and integrated with FAO's **AGROVOC**, aim to improve communication and understanding in land management by standardizing concepts. The tools support education, training, and community engagement – which is what the WG is all about
